**1. PAYMENT CONDITIONS**

Unless credit terms have been agreed to in writing prior to order, goods are only available C.O.D.

**2. LIMIT OF LIABILITY**

No claims for faulty or damaged goods will be entertained unless notification of such faults or damage is made at the time of delivery or collection.

No liability for indirect or consequential loss will be accepted for product faults, unsuitability, excessive tolerances, colour variances or failure to deliver, or for any other cause whatsoever. Liability is limited solely to replacement of product or refund on return of goods.

**3. SUITABILITY FOR USE**

It is the purchaser's responsibility to determine that the product or surface finish is fit for the intended end use.

Note that anodizing is 10um, except for 700 Series Shopfront material which is normally stocked in 20um.

**4. CANCELLATION OF ORDERS**

Orders for special anodizing or powdercoating cannot be cancelled once processing has commenced.

**5. RETURNS**

Stocked goods **only** may be returned for credit provided they are returned in a new saleable condition. A handling fee of 15% will apply to all returns.

**6. TITLE OF GOODS**

Title of goods remains with ALMET until paid in full.

**7. DELIVERY AND CONDITIONS**

- ❖ Delivery will be made to dock or kerbside only.
- ❖ Goods directed to building sites will only be made available to your nominated representative.
- ❖ Receipt of goods must be signed for.
- ❖ Where delivery is unable to be effected in accordance with these provisions, goods will be returned to our store and the aborted delivery charged. (A second delivery will be charged when fresh receipt arrangements are made).
- ❖ Delivery charges - \$40 to Brisbane \$30 to Gold Coast Outside of these areas – Upon Request

**8. POWDERCOATING CHARGES**

A minimum coating charge for items other than stock items in black or white will apply

Most powdercoating costings in brochure are a guide only. Contact ALMET for a more defined costing

**NOTES:**

- 1) Some items in black and pearl white are normally held in stock.
- 2) Components such as Door Stops, Hinges etc are not counted as part of a minimum order and are charged in addition to the minimum charge.
- 3) Material will be invoiced at mill finish and powdercoating separately charged. (Non stock colours).
- 4) Certain powders attract a premium and prices are on application.
